1. INTRODUCTION:

Gateway Airport Authority Limited (GAAL) seeks to appoint a suitable, qualified, reputable, and experienced service provider to supply and install cold storage rooms.

2. SCOPE OF WORK

2.3 The Service Provider must supply and install a Backup generator

- SDEC 20 KVA Single phase silent diesel generator, incl. ATS (GKSD-22S).

3. EVALUATION CRITERIA

All quotations will be evaluated in terms of administrative and/mandatory requirements, and the preference point system.

1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or

at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;

4. POINTS AWARDED FOR SPECIFIC GOALS

- 4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:
- 4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—
